RESOLUTION 2023-R-10**A RESOLUTION OF THE JOHNSON COUNTY BOARD OF
COMMISSIONERS FOR THE TRANSFER OF ONE SMART SCAN THERMAL
IMAGING BODY SCANNER TO THE COUNTY OF TIPTON, INDIANA**

WHEREAS, Johnson County, Indiana by its Board of Commissioners (hereinafter referred to as "Johnson County") is a government organization providing services to the citizens of Johnson County, Indiana and is a disposing agent as that term is contemplated pursuant to Indiana Code 36-1-11-2; and

WHEREAS, the County of Tipton, Indiana ("Tipton County") by and through its Board of Commissioners ("Board"), is a government organization providing services to the citizens of Tipton County, Indiana and is a disposing agent as that term is contemplated pursuant to Indiana Code 36-1-11-2; and

WHEREAS, Johnson County by its Board of Commissioners has authority by law to own, possess, and control certain items of surplus personal property which is more specifically identified as:

- One (1) Garrett Metal Detector Smart Scan Thermal Imaging Body Scanner ("Scanner").

WHEREAS, the above-referenced Scanner is surplus and no longer needed by Johnson County; and

WHEREAS, Johnson County has authority by law to dispose of and transfer such items of personal property per Indiana Code 5-22-22-10; and

WHEREAS, Johnson County is desirous of disposing of and transferring such items of personal property in "as is" condition to Tipton County; and

WHEREAS, Tipton County is desirous of receiving ownership of such items of personal property being offered by Johnson County for use in providing services to its respective citizens; and

WHEREAS, Indiana Code 36-1-11-8 allows for the transfer or exchange of personal property between governmental entities upon terms and conditions agreed upon

by the entities as evidenced by the adoption of a substantially identical resolution by the governing body of each entity; and

WHEREAS, Johnson County and Tipton County have agreed that Johnson County shall transfer ownership of the above-referenced Scanner to Tipton County without the exchange of monetary consideration and in "as where is" condition; and


WHEREAS, upon Tipton County's adoption and acceptance of a substantially identical Resolution hereto and Tipton County's removal, at its sole expense, of the above-referenced Scanner from Johnson County's premises on or before December 1, 2023, such property shall become Tipton County's sole and exclusive property.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF JOHNSON COUNTY, INDIANA, that Johnson County does hereby adopt the above as findings of fact; and


IT IS FURTHER RESOLVED that upon approval by Tipton County of a Resolution substantially identical hereto and upon Tipton County's removal of the personal property referenced herein on or before December 1, 2023, ownership of the Scanner described above shall transfer to Tipton County for its exclusive use and control.


